The ULCT Resolutions and Bills Process: Your voice matters

From the 2015 local option transportation funding to the modernization of local direct democracy statutes in 2019, your participation in the ULCT resolutions process has made a positive difference on public policy. You can make one of two proposals: add to the ULCT policy platform via a resolution or suggest potential legislation.

I) Proposed resolution

Process: You can see the existing ULCT policy platform HERE. The platform includes topics from local sales tax to transportation funding and land use to water. Once you submit a proposed resolution, ULCT staff will prepare the resolution to present to the LPC/Resolutions Committee in August and September. If the LPC/Resolutions Committee endorses the proposed resolution, then the resolution proceeds to the general membership at the Annual Convention for ratification. ULCT members must submit a proposed resolution to ULCT staff by **August 1, 2023**.

How to proceed: You can offer a resolution to modify the existing platform or to add new topic categories or specific issues. Please address the following questions in your resolution proposal:

- 1) What is the topic category and specific issue?
- 2) What is the problem that you are trying to solve?
- 3) Does the problem affect many cities?
- 4) How does your proposed platform principle or solution align with our legislative prism?
- 5) Are you or is someone in your city willing to work with other ULCT members on the category or issue that your resolution references?

II) Bill proposal

If you have a proposal for potential legislation, please answer the following questions. ULCT staff will then take your proposal to the ULCT Board of Directors for prioritization. If the Board prioritizes the proposed legislation, then ULCT staff will strategize how to implement it and coordinate with the Legislative Policy Committee.

If the ULCT Board of Directors does not prioritize your proposal, then ULCT staff will not create an implementation plan. You can still proceed with your proposal independent of ULCT. If your proposal affects other cities, we request that you keep ULCT informed via staff and the Legislative Policy Committee.

- 1) What is the category and specific issue?
- 2) What is the problem that you are trying to solve?
- 3) Does the problem affect many cities?
- 4) How does your proposed solution align with our legislative prism and ULCT platform?
- 5) Who are the potential allies and opponents to your proposed bill?
- 6) Are you or your city willing to work on a task force on the category/issue?
- 7) What else do you want ULCT leadership to consider about your proposed bill?
- 8) Who is making the proposal?
